I/we further agree to indemnify the Town of Pelham Parks and Recreation Dept., their agents and employees from any and all liability, loss or damage including but not limited to bodily injury, illness, death or property damage which the Town of Pelham Parks and Recreation Dept., their agents and employees become legally obligated to pay including reasonable attorney's fees and costs, as a result of claims, demands, costs or judgments, again the Town of Pelham Parks and Recreation Dept. their agents and employees on account of injury to the person or property or resulting in the death of the name participant except in the case of gross or willful wanton negligence of the Town of Pelham Parks and Recreation Dept., their agents and employees and whether or not such liability is sole, joint or several.

I/we am aware that participation in this program may present a strain on my child's body, or its parts and therefore I represent to the Town of Pelham Parks and Recreation Dept. that to the best of my knowledge, my child is in proper physical condition to allow him/her to participate and that I/we assume the risk of participating.

I/we understand that in case of injury or illness, I/we will be notified. If it is impossible to contact me and it is an emergency, I/we hereby give permission to the attending physician to treat, hospitalize, administer anesthesia or to order injections or surgery for the safety of my child.
