Gentlemen:

It is our desire to donate to the Pelham School District, cash and/or marketable securities with a value approximating \$60,000 on/or before November 30, 1976 subject to the conditions as hereinafter provided:

1. The gift must be accepted by the Pelham School District on/or before November 30, 1976.
2. The proceeds of the gift are to be specifically designated and expended solely for the design, construction, and maintenance of no less than four (4) regulation tennis courts to be located on property contiguous to Pelham High School. The courts are to be lighted, of sound construction, and surrounded by standard, high gage metal fencing.
3. Construction, maintenance and supervision of the tennis courts is to be the responsibility of the Pelham School Board or its appointed designees.
4. The courts are to be for the primary use of the Pelham School departments' athletics and scholastic programs with an understanding that when subject courts are not being used, they are to be made available for use by all residents of Pelham.
5. The Pelham School District must have executed a binding written commitment for the construction of the aforementioned tennis facilities on/or before eight (8) months following the gifts acceptance. Failure to have a binding commitment by that date will cause an immediate vesting in all unexpended funds resulting from this gift to the Daniel Webster Council, Inc. (New Hampshire Chapter of the Boy Scouts of America), who shall be a party in interest to the gift only to the extent of such eventualities.
