

Subject: Donations for All-Persons Trail Trust Fund

Good Morning Ed,

Last night, the BOS voted to create the All-Persons Trail Trust Fund that we have been communicating about. They accepted the following donations totaling \$28,500 to go into the fund:

\$25,000 from the Council on Aging - We do not yet possess the actual check and *there was a question last night on who the payee should be*. I think it should be payable to Town of Pelham just like the other checks. Could you please confirm for us?

\$1,000 from the VFW. The check the Trustees will receive is from Town of Pelham to Town of Pelham since the recreation department inadvertently

deposited the check. See attached correspondence.

\$2,500 from the American Legion. See attached copy of check.

We will get minutes and checks to you once available.

Now that the fund has been created ***should future checks still be payable to Town of Pelham or something else?***

96 Ms. Abare noted that this donation is from a great company and is made in America. She
97 thanked Mr. Gould for his assistance with the donation.

100 **Acceptance of two donations for the construction of the “All-Persons Trails” in the amount**
101 **of \$1,000.00 from the John H. Hargreaves Memorial Post 10722 VFW and \$2,500.00 from**
102 **the American Legion Pelham Post 100. To further establish a new trust account called the**
103 **“All-Persons Trail” that will be held by the Trustee of the Trust Funds.**
104

105 Al Steward, 6 Vista Drive, approached the Board. Mr. Steward explained that they held a
106 meeting last Monday at the Pelham Council on Aging where they voted to donate \$2,500.00 for
107 the All Persons Trail in addition to the donations already listed. He explained that they have been
108 working closely with the Conservation Commission and the Forestry Committee, who both
109 agreed to expend up to \$25,000.00 for the trail. Mr. Steward explains that after all of these
110 donations are accepted, they will have more than half of the \$150,000.00 they need to raise for
111 the trail.

113 Chairman Croteau added that Doug Hurst of Hurst Lumber has cut down all the trees they
114 needed to at the location and donated his time when doing this. This donation is worth around
115 \$2,000.00. Chairman Croteau stated that the community has come together to help get this
116 project done.
117

118 Town Administrator Roark explained that because the donation amount is over \$10,000.00, they
119 do not have to make the first motion any longer, because that is for trust funds under \$10,000.00.
120 They can go straight to the second recommended motion.
121

122 Chairman Croteau stated that he believes more committees will be making donations as well.
123

124 **MOTION:** (Corbett/Bergeron) To accept \$25,00.00 from the Council on Aging intended to
125 provide funding for renovations to the Mariam Farms conservation area to create
126 an All Persons Trail, and to direct the funds be held by the Trustees of the Trust
127 Fund in a new trust account called the All Persons Trail Trust Fund. The
128 Selectmen will use this trust fund to accept any future private donations for the
129 All Persons Trail project. Disbursements to be made by further vote of the Select
130 Board as agents to expend related to the purposes of the All Persons Trail Trust
131 Fund. The Selectmen are authorized to create a private trust donation fund under
132 the provisions of RSA 31:19 on a 1991 warrant article number nine.
