To the Town of Pelham (hereinafter called OWNER): In compliance with your Advertisement for Bids, BIDDER hereby proposes to perform all Work for the SURREY LANE EXTENSION, PELHAM, NEW HAMPSHIRE in strict accordance with the Contract Documents, within the time set forth therein, and at the prices stated below.

By submission of this bid, the BIDDER certifies, and in the case of a joint bid, each party thereto certifies as to his/her own organization, that this bid has been arrived at independently, without consultation, communications or agreement as to any matter relating to this bid with any other BIDDER or with any competitor.

The BIDDER declares that no person in the employ of the OWNER is particularly interested in this proposal or in the Contract for the work which he/she proposes to do, that he/she has carefully examined the Contract and Specifications and has informed him/herself fully in regard to all conditions pertaining to the site where the Work is to be done and has carefully estimated the work. He/she understands that the OWNER, its agents and employees, are not to be in any manner held responsible for the accuracy of, or bound by, any estimates or plans or locations of underground structures relating to the Work, and that if any have been given or made, they are to be considered solely as a base for filling out and comparing the several proposals.

The BIDDER proposes to furnish all the labor, equipment and materials required for carrying out the Work in accordance with the accompanying Construction Documents prepared by Keach-Nordstrom Associates, Inc. and Drawings prepared by Edward N Herbert Associates, Inc. for the sum specified herein, subject to additions and deductions according to the Specifications, and in all respects according to the terms thereof. The BIDDER agrees to furnish all labor, equipment and materials required for carrying out the work specified herein without the benefit of Asphalt Cement or Fuel Adjustment provisions.

BIDDER hereby agrees to commence Work under this Contract on or before the date to be specified in the Notice to Proceed. Substantial completion of the work specified and installation of binder pavement over Surrey Lane shall be completed on or before June 21, 2013. Wearing course pavement and other incidental work items specified or ordered shall be completed on or before June 28, 2013 unless otherwise directed by the OWNER. In the event all Work is not fully complete by that date, the BIDDER agrees to pay, as liquidated damages, the sum of \$100.00 for each consecutive calendar day thereafter.

The BIDDER proposes and agrees that within ten (10) days after the day on which Notice of the Award shall be given or mailed to him/her at the address hereinafter given, he/she will sign three (3) copies of the Agreement provided in Section 00531 - Agreement, and will execute and deliver to the OWNER the executed Agreement together with insurance certificates and bonds in the sums specified, conditioned to faithfully furnish and do everything required of the CONTRACTOR, with a surety company duly authorized to conduct business in the State of New Hampshire.


