

Raymond Park Town Forest--Terms of the Sale

- The successful bidder of this timber sale will be the highest bidder, so long as the bids reflect
 the current market value of stumpage as determined by the Agent.
- This is a per thousand sale requiring the successful bidder to put down 10% of the bid upon signing the contract, with the 90% balance being paid on a weekly basis as harvesting progresses. Mill scale slips will also be provided along with payment on a weekly basis.
- 3. This harvest must be conducted during the fall/winter months. (Nov-March) A two-year contract will be given to complete the harvest. The operation must be conducted as a conventional harvest, using cable skidders and lopping the tops of the trees in the woods. Some of the large diameter white pine will need to be cut in half before being skidded to the landing. Once the operation has begun, the contractor will stay to complete the harvest unless shut down by the Agent because of poor ground conditions.
- The Buyer will provide Workman's Compensation and Liability Insurance certificates to the seller before the job begins.
- 5. A performance bond of \$1000 will be required of the successful bidder.
- The timber tax has been waived.
- 7. The Seller/Agent will be responsible for completing the Minimum Impact Wetlands Permit.
- The landing will be constructed at the expense of the Buyer. Plowing the road leading into the landing will also be the responsibility of the Buyer; your bids should reflect these costs. Please see the attached sketch for more details.
- 9. The skidder will not be allowed to leave the site at the end of the job until the blocks have been pushed back into the woods and the landing has been regraded. The landing will be cleaned off and waterbars put in place within 10 days of the completion of the harvest, after which the \$1000 bond will be used to perform these duties at the Agent's discretion.
- The hardwood sawtimber has been tallied to a 10-inch tip using the 1/4-inch International Scale.
- 11. The softwood sawtimber has been tallied to an 8-inch tip using the 1/4-inch International Scale.
- No trash will be left on the landing or in the woods during the operation or after the job is completed.
- 13. A standard Bay State Forestry Service Forest Products Sale Contract will be signed by the Seller, the Buyer, and the Agent before the harvest commences.
