Agent must deem that construction is satisfactory before payment will be authorized.

Payment will be made within 30 days after completion of job.

No work to be done on Sundays or between 8PM-7AM.

Job is to be completed by July 31, 2007.

Job Spec's.

A forestry access road is to be constructed from the end of Nature's Way cul-de-sac into the woods to the designated landing area. Stumps are to be spread out on the low side of the landing. Note the following minimum specifications for road-building:

- a) 1 15-yard load of 3" minus stone at edge of pavement
- b) 1 15-yard load of #9 stone for stone ford, installed per BMP spec's
- c) 1 15"x20' double-wall plastic culvert, installed with headers
- d) at least 90 yards of bank-run gravel for the access road
- e) trees to be cut may be removed, or piled on landing at the end of the job, but tops must be broken down and lopped to a height of no more than 3 feet.
- f) large boulders to be placed at the edge of the tree line to block off the road

The parking area will be cleared, stumped, graded, and graveled. An access road (usable by domestic vehicles and tractor trailers) is to be constructed off the northern edge of Sherburne Road into the woods to the designated parking area, with sloping that meets the specifications in the driveway permits with adequate sloping, etc. Stumps are to be spread out on the low side of the landing. Note the following minimum specifications for road-building:

- a) 1 15-yard load of 3" minus stone at edge of pavement
- b) 10 15-yard loads of processed gravel covering the parking area with 9" of gravel, and 75 yards (about 5 loads) of the same to cover the entrance road with one (1) foot of gravel
- c) 1 12"x40' double-wall plastic culvert, installed with headers
- d) Estimated 45 yards of bank-run gravel as fill over the culvert for the access road
- e) Brush piles in work area to be placed off to the side, loam to be pushed off and stockpiled
- f) Any large boulders to be placed at the edge of the parking area
