Proposal #1

Section II, B, 1

Change From:

A chairman, Vice Chairman shall be elected at the **first regularly scheduled** meeting following Annual Town Meeting, **but** not later than April 30.

Change To:

A chairman, Vice Chairman shall be elected at the **organizational** meeting following Annual Town Meeting, **which must occur** not later than April 30.

Rationale:

The use of the word "regularly" confuses it with the "Regular Meetings" that are defined in Section VI. This is occurring at the organizational meeting and should be specified as such in this section.

Proposal #2

Section VI, A, 5

Change From:

PUBLIC HEARINGS – **On** the budgets recommended by the committee, shall be scheduled by majority vote of the committee, and that legal notice required by RSA 32 and any other applicable state statute given to the public. Normally hearings shall be on separate dates for the town and the school budgets but a single hearing date for both may be scheduled by majority vote of the committee.

Change To:

PUBLIC HEARINGS – **Public hearings pertaining to** the budgets recommended by the committee, shall be scheduled by majority vote of the committee, and legal notice required by RSA 32 and any other applicable state statute given to the public. Normally hearings shall be on separate dates for the town and the school budgets but a single hearing date for both may be scheduled by majority vote of the committee.

Rationale:

Poor wording as the item section heading "PUBLIC HEARINGS" should not be used as part of the first sentence. It makes the section confusing when read.

Proposal #3

Section VI, D

Change From:

A quorum shall consist of a majority **of six members** of the Budget Committee Including the appointed members from the Board of Selectmen and the School Board as provided by RSA **21**:15.

Change To:

A quorum shall consist of **at least** six members of the Budget Committee **inclusive of** the appointed members from the Board of Selectmen and the School Board as provided by RSA 32:15

Rationale:

You cannot say majority and then specify a hard number. The intention of the board when this was written was to make sure there were at least 6 members present for quorum. A more generic verbiage is better as defines the absolute number of 6 for quorum. RSA 21:15 has to do with Joint Authority and has nothing to do with the operation of the budget committee. Section 32:15 covers who is counted as quorum.

Proposal #4

Section VI, E, 8

Change From:

Adjournment – motion for adjournment will not be in order until **the completion of the meeting to** adjourn at a specified time.

Change To:

Adjournment – motion for adjournment will not be in order until **all business before the committee has been completed or tabled**.

Rationale:

The current verbiage is confusing and inaccurate. It needs to specify the condition where the motion is valid. Specifying a time for adjournment is a separate topic and can be added to this section later if required.

Proposal #5 - TABLED

SectionVI, G

Remove subsections 1 and 2

Rationale:

The choice of secretary is already covered in Section II, B, 1. We no longer "employ" the secretary as the position is fully funded by the BoS. Leaving these 2 subsections is inaccurate.

Proposal #6

Section VI, H, 11, b

Change From:

A matter shall be reconsidered or rescinded at a subsequent meeting in the same budget year by an affirmative vote of a majority of the budget committee members present at that meeting, at which a quorum is present.

Change To:

A matter shall be reconsidered or rescinded at a subsequent meeting in the same budget year by an affirmative vote of a majority of the budget committee members present at that meeting, at which a quorum is present.

Rationale:

RSA 21:15 has to do with Joint Authority and has nothing to do with the operation of the budget committee. Section 32:15 covers who is counted as quorum.
