RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of the permission granted the participant in the Pelham Parks and Recreation Summer Camp Program field trips, I/we shall release, waive, discharge, and covenant not to sue the Town of Pelham Parks and Recreation Dept., their agents and employees from all liability for any and all loss or damage and any claim or demands thereof on account of injury to the person or property or resulting in the death of the named participant except in the case of gross or willful wanton negligence of the Town of Pelham, Parks and Recreation Dept., its agents and employees or otherwise while the named participant participates in the Pelham Parks and Recreation Summer field trips.

I/we further agree to indemnify the Town of Pelham Parks and Recreation Dept., their agents, and employees from any and all liability, loss, or damage including but not limited to bodily injury, illness, death, or property damage which the Town of Pelham Parks and Recreation Dept., their agents and employees become legally obligated to pay including reasonable attorney's fees and costs, as a result of claims, demands, costs or judgments, again the Town of Pelham Parks and Recreation Dept. their agents and employees on account of injury to the person or property or resulting in the death of the named participant except in the case of gross or willful wanton negligence of the Town of Pelham Parks and Recreation Dept., their agents and employees and whether or not such liability is sole, joint or several.

I/we are aware that participation in this program may present a strain on my child's body, or its parts and therefore I represent to the Town of Pelham Parks and Recreation Dept. that to the best of my knowledge, my child is in proper physical condition to allow him/her to participate and that I/we assume the risk of participating.

I/we understand that in case of injury or illness, I/we will be notified. If it is impossible to contact me and it is an emergency, I/we hereby give permission to the attending physician to treat, hospitalize, administer anesthesia, or order injections or surgery for the safety of my child. I/we understand that my child may be photographed or videotaped during participation, resulting in social media postings. I/we, the parent/legal guardian, the undersigned, have read this release and understand all its terms. I/we execute it voluntarily and with willful knowledge of its significance. Xtreme Craze (Londonderry, NH) - Monday, July 15, 2024

Website: <https://www.xtremecraze.us/> \$48.00 price includes bus transportation, 2-hour jump/play time in the inflatable air park, forty-five-minute session of laser tag, \$5 arcade card and lunch (which includes two slices of pizza per child and unlimited fountain drinks). **Reminders: A waiver will need to be signed in advance by parents; Campers must wear socks.** The bus will leave at about 10:00 am and return to camp at about 2:30 pm.

Canobie Lake Amusement Park (Salem, NH) – Friday, July 26, 2024

Website: www.canobie.com - \$54.00 price includes bus transportation, day admission to rides, and waterpark. **Reminders: Children must bring money to purchase lunch/drinks. Please be sure children have sunscreen on and bring a towel and bathing suit if desired.**

****Late Return.** The bus will leave camp at about 10:00 am and return at about 5:30 pm.

Lego Discovery Center – (Somerville, MA) – Monday, July 29, 2024

Website: www.legodiscoverycenter.com/boston/ - \$29.00 price includes transportation and admission to center to explore over two million bricks, all rides, exhibits, and movies. Campers bring their own lunch.

New England Water Park – (Danvers, MA) – Wednesday, August 7, 2024

Website: www.waterparknewengland.com - \$54.00 price includes transportation, admission to waterpark and cabana and party room – campers to bring lunch, bathing suit, towel.

Chunky's Cinema and Pub (Pelham, NH) - Monday, August 12, 2024
