I/we am aware that participation in this program may present a strain on my body, or its parts and therefore I represent to the Town of Pelham Parks and Recreation Dept. that to the best of my knowledge, I am in proper physical condition to allow myself to participate and that I/we assume the risk of participating. I/we understand that the above program is at the Windham Country Club and I/we accept full responsibility for the transportation of me to and from these activities and I/we release, indemnify and hold harmless persons providing any transportation. I/we understand that we must be present during the classes or leave an emergency medical card with the instructor.

I/we understand that in case of injury or illness, I/we will be notified. If it is impossible to contact me and it is an emergency, I/we hereby give permission to the attending physician to treat, hospitalize, administer anesthesia or to order injections or surgery for the safety of myself. I understand it is my responsibility to leave an emergency medical form with Parks and Recreation and that photos or videotaping of this program may appear on the P&R website and give my permission.
