Site Plan review for a 65-unit apartment building on a 30.5 ac parcel subdivided off of the parent lot where the existing house will remain on 14 acs. Per order of the NH Housing Appeals Board, the Planning Board's denial of the application for site plan approval, the application for WCD special permit, and the request for waivers is REVERSED and REMANDED. The scope of the remand ordered is limited to allowing the Planning Board to impose reasonable conditions of approval.
