-The Town of Pelham, NH 2016 property tax rate has been set at \$20.95 per thousand dollars of property valuation, a decrease of \$2.31 (-11%) from 2015. The breakdown of the tax rate is: Town Government - \$6.02, a decrease of \$0.88; Local Education (school) - \$11.62, a decrease of \$1.03; State Education tax - \$2.082, a decrease of \$0.34; County tax - 1.23, a decrease of \$0.06.

-As a reminder, the winter parking ban will be in effect on December 1, 2016.
