Discussion about funds for Agricultural Commission versus Farmer's Market and how the funds are recorded. The funds are all in one account, but discussion about keeping separate ledgers. There are concerns about using Farmer's Market funds for Agricultural Commission purposes and vice versa. Mr. Doherty stated that he can keep separate ledgers starting in January.

- Community Outreach Ms. Cooke has reached out to the High School about any students that may want to come play music at the Farmers Market next year. She has established contacts and will continue to work on this. Discussion about getting more town groups to use the Community Tent at the Farmers Market.
