<u>75 Foot Buffer Zone</u>: Last meeting the Ag Commission felt it was a good idea to squash any formal request for the buffer zones. The subject was further discussed how if we have land that is marked as agricultural land, it would be good to know if new construction was being planned and to go to board meeting with request for larger buffer zone, tree line buffers, etc.
