COMMUNITY COMPOSTING

Ms. Takesian spoke with Rhonda at the Transfer Station and got some positive feedback

The Commission discussed the Town's of Hollis and Amherst and the ways those towns operate their composting.

A company can bring in barrels and haul away which takes the weighted items out which would be good for the town

Ms. Larson offered discussion on how the compost needs to sit so the residents can come and collect /use for themselves.

Mr. Doherty offered discussion on how the compost can pile up and would require three (3) bins to alternate turns for the compost. Concrete blocks can be use if needed.

Ms. Larson and Mr. Doherty discussed a rotating composting station.

The commission members discussed the benefit of a compost station where the residents can come by and grab compost with a bucket, there is no smell to compost, and it has been very beneficial and working well for other Town's.

Ms. Larson offered discussion for those who burn trees, and such the ash can go into the compost.

The Commission members agree that starting small with compost stations and hauling away to begin. If is growing into something bigger than option 2.

Ms. Takesian requested to reach out to Rhonda from the Transfer Station to see if she can attend the next Agricultural Commission meeting.

The Commission members were in favor of Ms. Takesian's request and Ms. Larson will reach out to Rhonda at the Transfer Station.
