- Old class 6 road repair Paul and Jason's plan:

Project is done and looks great-Update (Paul)

Made the class A trails more passable for fire trucks for safety.

• Ordinance to make target practice illegal in the town forests Update- (Paul)

- Five Easy Walks in the Woods Update Age Friendly Trails (Deb)
- 1. Wolven- Complete
- 2. Little Island Pond- Complete
- 3. Costa- Almost Complete bench, signage and bridge ramps still to be done
- 4. Merriam Farm- Complete
- 5. Gumpas Pond- Blue trail loop- Needs some work.

Age Friendly Trail Proposal – Gumpus Blue Trail Loop (Deb) Need more work in 2 places with water bars to help slow down the erosion which is causing a significant divot on the trail, making it challenging for senior hikers. Deb proposed a new water bar idea to help correct the erosion depression.

Deb has the volunteers for the work.

Materials for this project is to be determined.

Project to be started in 2023

Proposes 2 new benches around the beaver pond.

Tim believes this project may be a bit pricey. Tim will work very closely with Deb to help assess the work, materials and execution on this project

Paul motioned support of funding Deb's efforts to make the Gumpus trail an age friendly "easy walk" trail, and the work at Wolven.

• Revision of Merriam Cutter Forest Management Plan (Deb) Deb advises the committee that adding the deeds to our town forestry management plans to make deed referencing easier for our committee for years to come. These deeds are public knowledge, we are simply just adding the deed to the town forests file. Deb wants to add a language change to the Merriam Cutter Forest's management plan to say, "Copies of the three deed restrictions are attached." This lets the public see that the parcel was voted in as a Town Forest in 2006 and 2008. This allows the public and committee members to see the updates and history of each town forest.

Paul motioned to support Deb to move forward with this Charlie 2nd

Motion passed: 4-0-0

• Wolven – Rare plant –NH Natural Heritage Bureau (Deb) 3 rare plants identified.

Deb worked with the NH Natural Heritage Bureau resources - They recommended a plan to improve the habitat of one in particular rare plant species along the gas lines: The Bird Foot Violet.

Plan is to : Clear out some of the brush that is encroaching this rare plant to give the plant more room to grow. Work will be done by volunteers in November 2023

-All committee members in agreement of this project-

• Wolven- Trail damage with camera as a solution (Deb) Wolven has had constant dirt bike damage. 4 police reports have been filed because of the dirt bike and vandalism.

Solution: Deb proposes to use a camera for the police to monitor.

Paul propose to move one or two gate camera/s instead of buying a new camera-

• Moonshadow Dr- no blocking gate/parking sign update (Nick) Nick was not sure what kind of sign to get. We cleared up the confusion tonight. Nick will find a sign this week.
