The Committee discussed the steps associated with drafting a Power Plan, identifying a third-party service provider (Power Partner), and all of the major milestones and timeframes associated with each. The following sections identify each milestone and related (tentative) timeframes. Members will review existing Power Plans of other NH municipalities and other resources. Sharon Jozokos will compile the benchmarks below in a draft timeline.

Power Partner Process:

July 2023 – Gather utility data (Brett) Pro/Con list from neighboring towns on power partners (Brett) Aug 2023 Thru Sept – schedule interviews

Power Plan Process:

Jul 2023 – Develop draft plan Aug 2023 – Distribute draft plan to members to review Oct 2023 – Finalize Draft plan for submission to Board of Selectmen Dec 2023 – Final draft (obtain necessary approvals from Board of Selectmen, Town Legal, and possibly the Public Utilities Commission (PUC))

Warrant Article Process:

Jan 2024 – Submit draft Warrant Article for review and approval by Board of Selectmen Feb 2024 – Deliberative Session discussions on Warrant Article Tuesday, March 12, 2024 – Town Meeting Day – Warrant Article up for vote

Preliminary Educational Campaign and Info Sessions:

July 2023 to June 2024 basic media outreach Nov 2023 to Dec 2023 – Public hearings

Future Meeting Schedule:

July 12, 2023, 6:00pm July 26, 2023, 6:00pm August 10, 2023, 6:00pm August 24, 2023, 6:00pm
