(RSA 39:3)

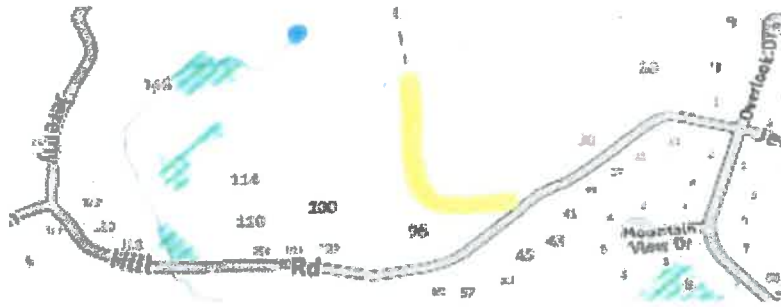

“Shall the citizens of Pelham vote to discontinue Gibson Road, so-called, between the present terminus of the existing Class VI portion of Gibson Road, which provides access to the location of a former State fire tower and the Jeremy Hill Natural Area, and Jeremy Hill Road between Tax Map 13, Lot 3-168, known as 96 Jeremy Hill Road, and Tax Map 13, Lot 3-167, known as 30 Jeremy Hill Road, pursuant to the provisions of RSA 231:43?”

From end of Class VI to undeveloped outlet on Jeremy Hill Rd between plots 96 and 30

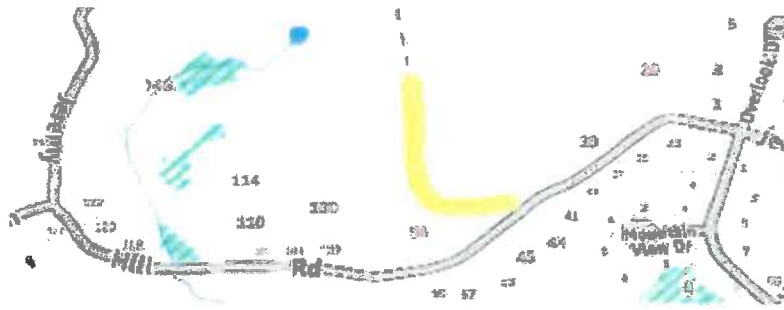

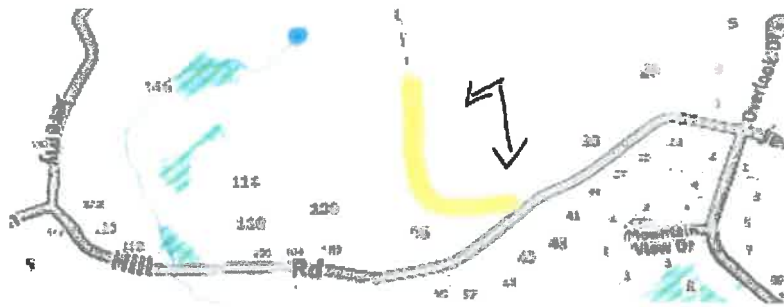

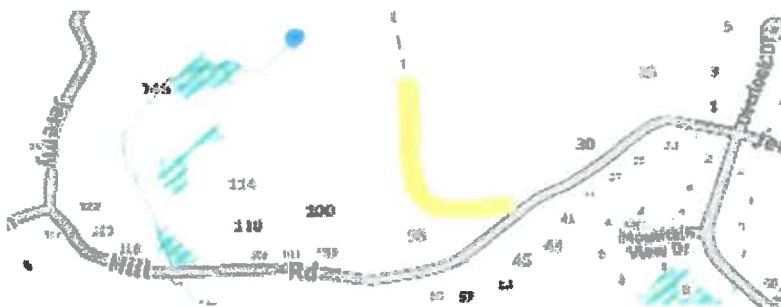
